#### **Fiscal Year 2018**

The Foundation for Excellence fiscal year 2018 allocation was set in the amount of \$27,512,225 following public

presentations and discussion before City **Commission on December** 11 and 18, 2017, and a vote of the City Commission on January 2, 2018. Of this sum, \$15,084,225 was directed to stabilization of the City's budget and

lowering the City property taxes from 19.0275 mills to 12 mills. Furthermore, \$12,428,000 was allocated for aspirational City programs. In 2018 new programs were added and successful programs were expanded and enhanced.

#### **Budget Stabilization**

We know that if the City's budget is stable, then service and staffing will not be reduced due to budget challenges and may adapt to changing needs. Additionally, assets and services can be aligned to make the Imagine Kalamazoo 2025 Strategic Vision a reality through highly impactful and equitable aspirational projects.

**Tax Reduction** 

Regarding the significant investment in tax reduction, a reduction in City property

properties. taxes on all should, over the long term, correlate with beneficial to the prosperity effects of all residents, to overall pricing or quality of housing stock, including rentals, as

well as business retention or start-up. The City is tracking numbers for property

tax delinguency rates and total parcels delinguent dating back a decade in order to set a baseline for modeling the long term impact on homeowners and businesses.

#### Foreclosure Prevention

In 2018 a grant of \$40,000 helped 33 families avoid foreclosure, and allowed work to be done, the first of its kind in Kalamazoo, to ensure that no owner occupied homes

on the Northside were foreclosed for nonpayment of taxes.

The program makes use of the County's existing criteria and one-on-one financial counseling to reach those homeowners who have not only the greatest need, caused by a medical emergency for example, but also the highest likelihood of succeeding in exiting arrears permanently. This success resulted partially from door-to-door outreach.

Keeping people in their homes prevents many avoidable economic and social outcomes that result from housing insecurity - especially for children and the elderly.

#### **Aspirational Support**

In the expand and enhance category are the City's flagship youth development and career preparation programs, MyCity/

YOU, SuperRec, and All Things Possible, the lead water service replacement initiative, and park and infrastructure enhancements occurring under the name of Great Neighborhoods. The partnership with the Local Initiative Support Corporation (LISC) to lead very substantial

housing initiatives continues in its second year. A notable aspect of this partnership is that City dollars are leveraging LISC dollars at a ratio of two-to-one. Further support for economic development. especially in the areas of small business and neighborhood support, is being implemented through the new Economic Opportunity Fund. In the area of new pilot programming is a unique partnership with Kalamazoo Public Schools, Metro, and Kalamazoo Public Library called the Youth Mobility Fund that gives unlimited free bus ridership to City youth in grades 9 - 12.

The Foundation for Excellence (FFE) is an innovative 501(c)3 non-profit support corporation that was created in 2017 to address systemic challenges to the prosperity of Kalamazoo. The FFE was originally announced alongside a commitment of \$70.3 million to support its creation, and to stabilize the City's budget, lower the property tax rate, and invest in aspirational community projects through 2019. Todate, the FFE has supported many City projects and programs that are impacting the lives of all residents, including many street and sidewalk projects, a historic partnership with the Local Initiative Support Corporation (LISC) for economic development and affordable housing, doubling the pace of lead water service removal, expanding youth development and employment programs, and multiple, significant park improvement projects.

A fundraising campaign has also been initiated to raise and invest enough resources to support this kind of work forever.
